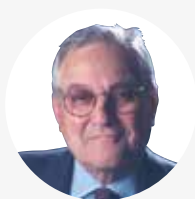

CHÂTEAU L'ÉGLISE CLINET

Château L'Eglise Clinet has a long history. It dates all the way back to the back to the late 1800s. Clos L'Eglise-Clinet was created in 1882. This happened when two families agreed to join together and form a partnership to produce Bordeaux wine together. The families were Mauleon Rouchut of Clos l'Eglise. And the Constant family, the owners of Château Clinet. From that point forward, until the mid-1950s, their Bordeaux wine was sold under the name Clos L'Eglise-Clinet.

After that date, the wines were released just as they are today, under the current name of, Château L'Eglise Clinet. Before Denis Durantou, the current owner and wine maker took over, his great-grandfather managed the property. The elder Durantou spent all his time as a shopkeeper. He did not live at the chateau. He preferred to spend his time on his dairy farm, located in Coutras.

Denis Durantou took over the winery in the mid-1980s. The property, slowly but surely keeps getting better and better. Today, it is one of the stars of Pomerol! The wine is concentrated, full-bodied, opulent and rich. Everything is in harmony. This special Bordeaux wine offers a purity of fruit, exotic spice components and freshness. The portion of old vine Cabernet Franc, which is close to 70 years of age is part of what makes this wine unique. Those vines are a large component of what separates the style and aromatic complexity of L'Eglise Clinet from the most of the other top Pomerol wines.

CHÂTEAU L'EVANGILE

By the 1780s the estate, then known as Fazilleau, was already some thirteen hectares (it is fourteen hectares today). Just prior the century's turning it was sold to a lawyer named Isambert, who changed the name to L'Evangile. The estate was up for sale again in 1862, this time bought by Paul Chaperon, and it stayed with his descendants (the Ducasse family) until its purchase by the Rothschilds of Château Lafite in 1990.

While not a big producer compared to the chateaux of the Medoc, L'Evangile manages around 5000 cases annually from its fourteen hectares holding. It is a typical Pomerol blend of eighty percent Merlot and twenty percent Cabernet Franc, all of which spends eighteen to twenty-four months in fifty percent new oak barrels.

L'Evangile is a wine of great refinement, poised, focused and with layers ripe silky fruit with a nice hint of graphite and earth.

BORDEAUX

CHÂTEAU AUSONE

Ausone is named for Ausonius, a fourth century poet and later Consul to Rome who lived in the area, although no proof exists that the current Ausone holdings and Ausonius were connected. What is known is that he owned vineyards in or near Bordeaux, and that since Roman times wine has been made in and around St Emilion.

From the early eighteenth century Ausone was owned by the Cantenat family, eventually passing to a nephew, M. Lafargue. Lafargue is credited with building Ausone's reputation at the time; during his tenure it was considered the finest producer in all of St Emilion. In the early 1890s it passed to Lafargue's niece, Madame Challon, who later married Edouard Dubois. Edouard Dubois-Challon continued the work of Lafargue and by the time of the First World War Ausone was considered the wine of the commune, even greater than Cheval Blanc. This success and reputation enabled Dubois-Challon to acquire neighboring Château Belair in 1916. Alain Vauthier, the current proprietor, is a descendant of the family.

For a long time Ausone had a reputation as an erratic performer, but more recently has begun to achieve its potential consistently. In 1989 Clive Coates wrote presciently in *Grand Vins*, "I dare say it will not be long before Ausone fetches the same prices as Petrus."

CHÂTEAU LÉOVILLE BARTON

Anthony Barton and his team have made an exciting blend of tradition and new technology here. The Château proudly looking down on the main road, the meticulously manicured grounds and the lovely big wooden vats in the cellar, all really have a wonderful air.

As the name suggests, it was originally part of the Léoville estate, which Hugh Barton purchased a portion of in 1826. Barton was a highly successful Bordeaux negociant from a family of wealthy Irish landowners. Even today, the Château has strong links to the UK, and Ireland remains its biggest market.

Léoville Barton's 25,000 cases come from roughly fifty hectares of vines planted to seventy percent Cabernet Sauvignon, twenty percent Merlot and ten percent Cabernet Franc. Average vine age is thirty-five years, with the oldest over the sixty year mark. Once vinified in the traditional oak vats, the wine spends eighteen to twenty-two months in sixty percent new oak casks.

Anthony Barton sees himself as very much a man of the people. He has led the fight against unreasonable pricing and continues to push quality to its limits For lovers of this estate, the news is all good.

A LITTLE BIT OF BORDEAUX, A LITTLE BIT OF BURGUNDY (LOTS 65-67)

Angélus and Liger-Belair...you can't go wrong here !

CHÂTEAU ANGÉLUS

Château Angélus has one of the longer histories in the St Emilion appellation. The de Bouard family has a long history in the region. In fact, the de Bouard family has been in Bordeaux for more than 700 years. They arrived in St Emilion in 1782. However, even though Château Angélus has been around for quite a while, the chateau does not have the same track record as the family. Compared to the current owners, Angélus is mere baby having been born in 1782. That was the year when Georges de Bouard began purchasing vineyard land in the St Emilion area.

Skipping ahead a few hundred years, Catherine de Bouard de Laforest began living at a St Emilion property known as Château Mazerat at the close of the 18th century. The true birth of what we know of as Château Angélus begins in 1909 when Maurice de Bouard de La Forest inherited the vineyard owned by his ancestor. In 1921, Maurice de Bouard de La Forest purchased a 3.5 hectare parcel of vines known as L'Angélus and the estate was born.

Château Angélus is still owned by the de Bouard family. In fact, since 1989, Angélus is considered one of the top estates in the entire Right Bank appellation. Hubert de Bouard is currently in charge of managing the family directed property. Today, all the children participate in running the estate. Prior to his tenure, the truth is, the property was not making wines as good as their terroir allowed.

Shortly after de Bouard began running the property, he instituted another change. He changed the name from L'Angélus to Angélus. He said, "This allows the wine to show up first in alphabetized lists." He was right! Château Angélus was one of the first chateaux to expand into China and Asia. In part, some of their initial success into China was due to their logo of the golden bell, where the wine is referred to as Kin Chung, The Golden Bell. In fact, Hubert de Bouard has always been a savvy marketer. He was one of the first people to connect with Hollywood when he negotiated the addition of Château Angélus into the plot of a James Bond movie!

BEAUTIES FROM JAYER AND EXTRAORDINARY ROUSSEAU IN MAGNUM (LOTS 69-72)

HENRI JAYER

It is interesting to reflect upon the fact that in many ways Henri Mayer is portrayed as a modernizer in Burgundy, as many of the techniques that he pioneered in the region have been embraced by legions of vignerons, but in many respects he represented a return to a very traditional approach to winemaking. His emphasis on viticultural practices and the meticulous care that he gave to his vineyards are simply the most obvious facets of his traditional methodology. Henri Mayer revolutionized winemaking during the course of his career. Amongst his very many accomplishments was his emphasis on limiting yields in the vineyard, allowing the cooled must to macerate for a few days prior to the onset of alcoholic fermentation to allow colors to set and adding to the aromatic complexity in the finished wine and bottling the wine unfinned and unfiltered.

He always spoke of the importance of treating the wine gently during the fermentation and élevage process, which he likened to “moving a sleeping baby who must be carried to its bed from the sofa upon which it has fallen asleep.” He also was a proponent of one hundred percent new oak for his wines. This was the one precept of his winemaking technique that cannot be described as traditional, and it is the one most often cited by modern winemakers when they seek to sprinkle a little of the “fairy dust” of Mayer inspiration on their own wines. There is little doubt that the concept that a Grand Cru “deserves to be raised in one hundred percent new oak” that is often heard in Burgundy these days can be traced back to Henri Mayer and his success with new wood. However, one of the interesting things I have always found about Henri Mayer’s wines was that I have never tasted one that was over-oaked.

DOMAINE DE LA ROMANÉE-CONTI

The domaine is known for picking very late, sometimes, as in 1978, later than any other producers. They prune endlessly, make many passes through the vineyards at harvest and sort grapes rigorously both in the vineyard and at the winery. Average age of the vines is around thirty-five to forty-five years with yields typically around thirty hl/ha. The wines are aged in new French oak casks for approximately twenty months. There is usually only one racking and since 1985 the wines from all casks in each cru have been blended together prior to bottling to reduce bottle variation. Recently they have been moving towards biodynamic viticultural practices. Like many of the region's leading growers they have seen concrete evidence of soil and vine health improvement. It's hard to imagine that these wines could get better, but that is what separates them from the rest of the pack: an unrelenting pursuit for perfection in the Pinot Noir grape. In addition to the majestic reds, a white is also produced from a plot in Montrachet.

Of all the wine world's luxury brands, Krug is perhaps the most glittering. No expense is spared in its production, though the techniques used are in fact remarkably artisanal, including fermentation in small, old wooden casks. Time is of the essence: the overall ageing cycle is the best part of a decade here, with all wines being aged for at least six years sur pointes (upended, after the "ordinary" ageing period that follows the second fermentation is concluded). No expense is spared, either, in the pricing of its five wines, the cheapest of which, Grande Cuvée, costs as much as many rival houses' top cuvees. This is a wine of magnificent complexity and layered richness, nourishing and diverting, as detailed and textured as a Gobelin tapestry. It contains wines from a decade's worth of vintages and from at least twenty different crus (not all of them Grand or even Premier, one might note); Krug makes no secret, too, of its need and love for Pinot Meunier. (The Krug 1928 vintage, regarded by the family as the greatest ever, contained twenty percent Meunier, and there is eighteen percent in the finely honed 1988.) There is also a relatively understated rose of pale tawny hue, and a series of vintage wines of magnificent stylistic oscillation, fully respecting the potential of each year. The Collection vintage wines have spent more years in the Krug cellars in Reims; disgorgement took place at the same time as for "ordinary" vintage wines. Finally, a champagne de terroir: the pure Chardonnay Clos du Mesnil, vinified from wines in a genuine 1.9 hectares walled vineyard within the village of Le Mesnil, purchased by Krug in 1971, and released as a vintage wine beginning with 1979. In great years (like 1988) it is magnificent and multi-dimensional.

LOUIS ROEDERER

Roederer did not get its present name until 1833, but was in existence as far back as 1760 under the name of Dubois Père & Fils. Roederer also owns several well-respected vineyards in other locations: Roederer Estate, Ramos Pinto, Haut-Beauséjour and Château de Pez. Today the firm is the most financially successful in the region, thanks largely to these vineyards, which supply Roederer with some seventy percent of its grapes. The house is now run by Jean-Claude Rouzaud who works according to the same principles as those applied in past decades...Roederer is without doubt a brilliant Champagne house with an exceptional portfolio of wines. The non-vintage Champagne is brilliant. The Rosé and Blanc de Blancs offer an aristocratic elegance typical of the house, and the vintage wine is always among the best. Cristal is today the most sought-after cuvée de prestige, and has perhaps the most appetizing appearance of any wine in the world. Cristal Rosé is not only the most expensive rosé Champagne—it is obviously the best. In my opinion, this house is one of the four best in all of Champagne. Every vintage is stunning.

CHÂTEAU LATOUR

Some of my fondest wine memories are of drinking wine bottles of the renowned Château Latour. It is, without a doubt, one of the greatest wine estates in the world. While its history goes well back to the fourteenth century, Latour began to be clearly defined as one of the greatest wine estates in the world in the mid-nineteenth century, and amazingly, It has kept that position for the last 150 years. Their wines, which are known for their power, richness and longevity, are sought after by collectors and wine lovers throughout the world.

As Robert M. Parker says of Château Latour in *The World's Greatest Wine Estates*, "The wine produced here has been an impeccable model of consistent excellence, in great, mediocre, and poor vintages. For that reason, many have long considered Latour to be the Médoc's finest wine... Latour remains one of the most concentrated, rich, tannic, and full-bodied wines in the world."

In 2000, I had the wonderful opportunity to taste over twenty-five vintages of Château Latour, including fourteen wines older than 1961 and four from the nineteenth century. It was an evening I will never forget. The wines were so rich, alive and fresh. What an extraordinary experience it was to be able to taste the 1900 and the 1899 side by side and discuss the differences, or to argue whether the 1955 or the 1949 is showing better right now (at my table we all thought the 1955 had the slight edge). In the end we tasted Latour from a 125 year span and although there was a lot of discussion about which were the better wines, the final conclusion of everyone in the room was that, "Latour makes some of the greatest wines that any of us have ever tasted."

CHÂTEAU D'YQUEM

Château d'Yquem is the apex qualitatively and the centre geographically of the Sauternes area. Each major property occupies its own little hill. Yquem's is the highest. It is also the largest estate, the most perfectionistic, the most consistent. Unlike the rest of the region there was no cutting of corners, no lack of investment, no dip in quality in the sad days of the 1960s and 1970s.

At Yquem we have Sauternes winemaking at its most perfectionistic. The vines are pruned to yield nine hl/ha – one glass per vine (as opposed to a full bottle in a classified growth red wine château). Collection of the grapes is berry by botrytised berry, rather than by bunch or half-bunch elsewhere. The grapes are crushed in a small horizontal hydraulic press in three stages. Unlike in Champagne, for example, the first pressing does not necessarily give the best wine. There is no débourage before the wine is put into cask. Fermentation and ageing is in new oak, of course, the latter taking place in a splendid underground cellar, constructed in 1987. The assemblage is late and the wine is not bottled for three years or more. Only then is it put on the market...

There is something very special, and indeed very consistent, about Yquem. The wine is more oaky than most in its youth. It is by quite some way the richest, most concentrated, most intense wine of its kind. In great years – I have a marginal preference for 1989 over 1990 and 1988 – it is nectar: the liquid quintessence of concentrated sunbeams, to quote Thomas Love Peacock.

LIGER-BELAIR

The current Domaine du Comte Liger-Belair was founded by Louis-Michel Liger-Belair only in 2000, but Liger-Belairs have been growing wine in Burgundy for nearly two centuries, since General Louis Liger-Belair purchased the Château du Vosne in 1815. Over the next century the domaine grew through marriages and purchases until it included the monopoles of La Romanée, La Tâche and La Grande Rue, and substantial holdings in many of the other greatest vineyards of the Côte de Nuits. Unfortunately the passing of Comte Henri Liger-Belair in 1924 and his widow the Comtesse in 1931 meant that the estate was to pass equally to their ten children, and the law of the time provided that for any of the heirs to receive their portion in land rather than cash, all must have reached legal adulthood. Two had not, and when three of the other siblings did not want to wait to receive their inheritance, there was no choice but to put the entire domaine up for sale.

At that auction, Louis-Michel's grandfather Comte Michel and one brother joined to purchase what they could, and walked away with three pieces of vineyard land in Vosne-Romanée, the monopole La Romanée and parcels of Reignots and Chaumes. The wines were released under the names of various negociants until Louis-Michel began to take back vineyards to produce the wines himself. He continues to refine his practices, most recently with a complete conversion to biodynamic farming and to gentler presses, which he believes has improved the quality of the tannins, and has in just a decade solidly re-established the Liger-Belair name as one of the most reliable producers of top class Burgundy.

GEORGES ROUMIER

The domaine was enlarged a number of times since its inception in 1924, with Georges acquiring a bit more Bonnes-Mares in 1952, as well as two parcels of Clos Vougeot in the same year. In 1953 the Roumiers also purchased the monopole Premier Cru Morey St Denis "Clos de la Bussierre." In 1968, Jean-Marie's wife, Odile Ponnelle, purchased a tract of unplanted Corton-Charlemagne, which was subsequently committed to vine and the first Roumier Corton-Charlemagne was released in the 1974 vintage. In 1978 the domaine finally purchased the small slice of Musigny that they had been sharecropping since the mid-1920s.

Domaine Georges Roumier is one of my favorite domaines in all of the Côte d'Or. In my personal cellar, by quite some margin, I have more Roumier wines than from any other producer. I find them to be extremely reliable for cellaring, and to deliver at their apogees all the majestic complexity for which Burgundy is rightly renowned. Out of the blocks they are not the typically delicate style of Chambolle, but rather wines that are full and well-structured in their youth. For young Chambolles they are atypical, but within the fullness of time, they develop all the silk and perfume for which the wines of this village are so rightly cherished. From the superbly crafted Chambolle-Musigny village bottling that I buy in depth in every vintage to the lonely bottle of Roumier Musigny, these are among the greatest wines that I have in my cellar, and bottles that I look forward to growing old with comfortably.

RENÉ ENGEL

René Engel was one of the most famous Vosne-Romanée estates until Philippe, René's grandson, died in 2005. Philippe had been making the wine at his grandfather's estate since the early '80s, under René's watchful eye, of course. The estate was famous for a classic style of Burgundy that focused on finesse and elegance, and less extraction. The Domaine was sold to François Pinault (owner of Château Latour and Christie's, among other things) after Philippe's death in 2005 and is now known as Domaine Eugénie, after Pinault's mother. The wines of René Engel are disappearing quickly as they're not being made, and the collectors who own them can't help but drink them.

NIKKA YOICHI DISTILLERY

Masataka Taketsuru, the controversial father of Japanese Whisky, began production at Yoichi in 1936 and named the distillery after the fishing town of the same name. Taketsuru, originally working for Suntory, left Suntory and Yamazaki in its early days for Yoichi on the northern Japanese island of Hokkaido because he believed it contained a similar climate to Scotland, and he wanted to make a Scottish style whisky. The whisky has become iconic in that its character is powerful but the whisky never loses its sense of balance.

Yoichi boasts many unique opportunities such as having their own peat for malting due to the location of the distillery and, in fact, Yoichi is the only distillery that still uses direct fire by charcoal to fire its stills rather than the steam that everyone else in the world is using. The result is a certain rusticity that can now only be found at Yoichi.

CARONI VELIER

Established in 1923 on the site of the sugar factory for which it was named, Caroni was a key ingredient of British Navy rations, where it's famous high ester 'Heavy' rums help to make up the signature flavour. Sadly, with the decline of the Trinidadian sugar industry, the Islands distillers became more and more dependent upon imported molasses, making distilling less and less economical. The writing then, was already on the wall when in 2001 the Trinidadian government sold a 49% share in the holding company to Angostura. Caroni was shuttered in 2002 and a Behemoth of flavour was lost to the world. Thankfully, in 2004, Luca Gargano discovered the ossuary of Caroni's warehouses filled of barrels of the legendary heavy rum quietly ageing. Since then we have seen a number of outstanding releases with collectors and drinkers alike seeking to acquire one of these coveted relics.

CHARTREUSE

Chartreuse: The elixir of long life holds a unique place both in the market, and in the cellars of connoisseurs. It's a beverage so unique, so steeped in history and shrouded in mystique, that it excites the heart, the brain, and the palate like few other drinks. It is rare, especially the older bottles and large formats, and despite the fact that it's a 400-year old beverage, it remains artisanal—the recipe is a secret and supposedly known by only two monks.

Today, there are five main kinds of Chartreuse. The Elixir Végétal, which is made from the original recipe, is highly concentrated (69% alcohol) and sold in small bottles. Green Chartreuse, with its bewitching natural green color, is made from 130 different plants (the precise recipe is known by only two monks at a time). Yellow Chartreuse is sweeter than green, and was introduced to the market in 1840. V.E.P. (Vieillessement Exceptionnellement Prolongé, or “exceptionally prolonged ageing”) Yellow and Green are the same as the regular Green and Yellow except, as the name suggests, aged for an extra-long time in oak.

Zachys reserves the right to withhold all property until such time as all outstanding amounts are paid in full from purchases from any prior auction(s). Upon receipt of full payment, Zachys will issue a Release Order, which must be presented in order for Zachys to release purchases made at auction. Subject to the foregoing, all lots are to be paid for no later than 4:30 PM (local time at the place of the auction) on the fourteenth calendar day following the live sale, and removed from Zachys' premises at Buyer's expense no later than 90 calendar days after the date of sale. 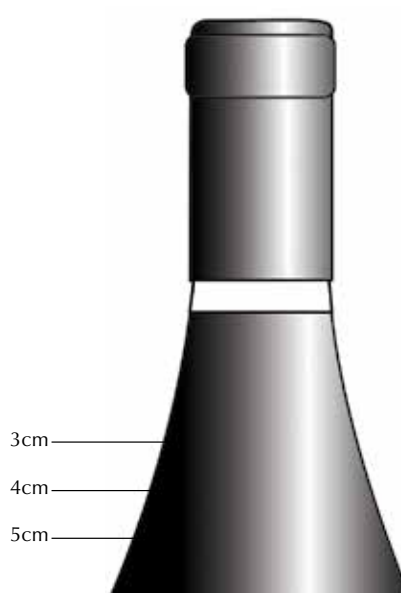
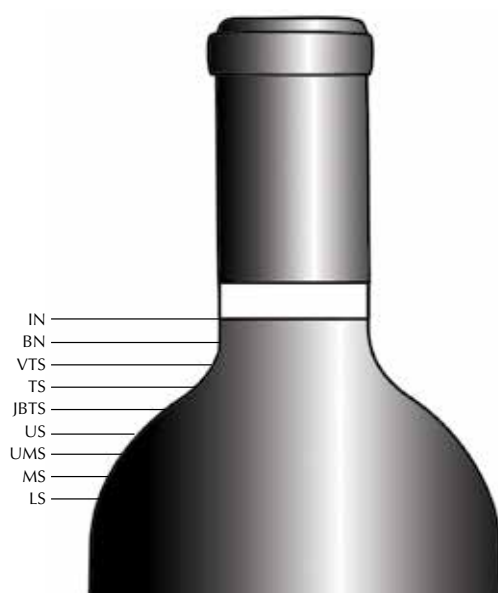

Level/Ullage Descriptions & Interpretations

- IN **Into Neck:** Excellent for a wine of any age.
- BN **Bottom Neck:** Excellent for a wine of 10 years or older.
- VTS **Very Top Shoulder:** Normal for any wine 10 years or older.
- TS **Top Shoulder:** Normal for any wine 25 years or older.
- JBTS **Just Below Top Shoulder:** Normal for any wine 30 years or older.
- US **Upper Shoulder:** Slight natural reduction through easing of cork and evaporation through cork and capsule. Very good for any wine over 40 years old. Excellent for any wine over 50 years of age.
- UMS **Upper-Mid Shoulder:** Good for any wine 50-60 years of age.
- MS **Mid Shoulder:** Probably some weakening of the cork. Very good for wines over 50-60 years of age. Estimates usually take this into account.
- LS **Low Shoulder:** Some weakening of cork acceptable if wine or label is exceptionally rare or interesting.

Because of the slope of shoulder, it is impractical to describe levels of Burgundy-shaped bottles as into neck, etc. Wherever appropriate, the level between capsule and wine will be measured and cataloged in centimeters.

The condition and drinkability of Burgundy are less affected by ullage than its equivalent from Bordeaux. For example, a 5 to 7cm. ullage in a 50 year old Burgundy can be considered normal, indeed good for that age; and 3.5 to 4cm., excellent for that age.

Champagne bottle measurements are done from the bottom of the foil to the level of the wine.

Label & Capsule Conditions

Labels and capsules can become soiled, stained, or otherwise marked, especially with wines over 20 years of age. Unless otherwise noted, label conditions will be appropriate for age, but Buyers should note that normal staining, discoloration or other conditions may not be noted if such conditions are appropriate for the age of the label. Potential Buyers are invited to make appointments to inspect wines personally.

Special Notices

Though every effort is made to describe or measure the levels of older vintages, corks over 20 years old begin to lose their elasticity and levels can change between cataloguing and sale. Old corks have also been known to fail during or after shipment. We therefore repeat that there is always a risk of cork failure with old wines, and Zachys assumes no responsibility for this.
